#### TERM & CONDITIONS FOR RUNNING THE STALL.

- 1. Furniture for the Stall will be provided by the licensee.
- 2. The firm should be registered with an appropriate government agency.
- 3. The contract shall be initially for a period of one year and may be extended for a further period at the discretion of competent authority.
- 4. A refundable security of Rs.5000.00 shall be deposited by the Licensee with the Institute on or before the execution of the License Deed.
- 5. Minimum License Fee will be Rs.500.00 per month or higher bid offered by the Licensee.
- 6. The minor work (maintenance) will be borne by the Stall contractor.
- 7. Monthly License Fee and water fee shall be deposited by the Licensee by the 7<sup>th</sup> of every of month of advance.
- 8. Monthly electricity charges will be paid by Licensee as per unit given by submeter @ Rs. 8-9 per unit. Water charges will be charged @Rs.100.00 per month. The charges would be deposited by the Licensee by 7<sup>th</sup> of every month in advance(\*subject to change as rates applicable from time to time)
- 9. If the Licensee fails to pay the License Fee, Water and Electricity Charges in time or does not abide to their terms and conditions of the License, the License will be terminated and it will be awarded to another party.
- 10. The quality of stuff/material will be of good quality and branded. The prices of all the items shall be fixed in consultation with Institute committee approved by the Registrar I/c and full price list shall be displayed on prominent places.
- 11. The Licensee shall be personally responsible for strict and genuine compliance of Municipal by laws relating to sanitary conditions and provide liveries to the bearers and waiters of the canteen.
- 12. Catering shall not be allowed to the outsiders, other than bonafide visitors to the Institute. The Stall will not be closed on any working day except with the prior permission of the Registrar I/c.
- 13. The Licensee will ensure a reasonably good quality variety and availability for longer hours of eatable items and ensure proper hygiene and aesthetics.

- 14. Menu and rate list should be displayed in the Stall written with white paint on black.
- 15. It will be the sole responsibility of the Licensee to abide by the provisions of the following acts as to the workers engaged by him for performance of this contract.
  - a. Minimum Wages Act 1948.
  - b. Employee Provident Fund Act 1952
  - c. Employee State Insurance Act 1948
  - d. Contract Labour (Abolition & Regulation) Act 1970.
  - e. Industrial Employment (standing orders) Act and rules 1946.
  - f. Prohibition of Child Labour Act 1986.
  - g. Payment of Bonus Act and Rules 1965.
  - h. Workmen compensation Act 1923
- 16. The Licensee shall not serve, except the prior permission of the Registrar in the classrooms.
- 17. The Registrar reserves the right to reject or accept any tender with out assigning any reason whatsoever.
- 18. Contractor Company must have experience of running the Stall in educational institutions.
- 19. The licensee shall furnish his shop with high quality furniture and start his business immediately, failing which the license shall be treated as cancelled.
- 20. Appropriate number of dustbins must be provided by the Licensee to maintain the cleanliness.
- 21. The agency/firm/company shall use only branded raw materials and best quality for preparing the food. In the event of the quality of the food served being poor or not adhered the contractual conditions IIITDM Kurnool will be free to impose penalty as deemed for on the agency/firm/company.
- 22. Stall premises should be neat, clean and hygienic. Strict adherence of the hygienic of stall and its surrounding is essential.
- 23. Contractor shall be solely responsible in case of incidences of food poisoning and shall bear the complete expenditure arising out of this for medical treatment of the users. In addition, penalty may be imposed on the contractor as decided by the Agency/firm/company Committee for such incidences.
- 24. The agency/firm/company should ensure that all the employees are free from communicable diseases. Medical Certificate to this effect should be available for inspection by the authorities. If any worker is found medically unfit, he/she may not be given permission to continue his/her duties and contractor has to replace them immediately without fail.

- 25. All expenses related to the functioning of the employees engaged by the agency/firm/company shall be in the scope of the agency/firm/company.
- 26. Liability/responsibility in case of any accident causing injury/death to stall worker or any of his staff shall be of the contractor. The Institute authorities shall not be responsible in any means in such cases.
- 27. The successful tender will have to make an agreement with IIITDM Kurnool on terms and conditions of the contract on a Rs. 100/- stamp paper, the cost of which will be borne by the contracting agency/firm/company.
- 28. The contracting agency/firm/company shall not be allowed to transfer, assign, pledge or sub-contract its rights and liabilities under this contract to any other agency.
- 29. The contracting agency/firm/company shall get suitable instructions from the Registrar / Designated Official of IIITDM Kurnool and shall provide the services promptly as per requirement.
- 30. The Registrar I/c, IIITDM Kurnool reserves right to withdraw / relax any of the terms and conditions mentioned above so as to overcome the problem encountered by the contracting parties.
- 31. The Committee of the Institute will over all supervise the stall operations.
- 32. The company / agency is responsible for removal and disposal of waste / garbage from daily stall operation.
- 33. The Company / Firm / Agency shall collect the charges from users and the Institute is not responsible for collection of any charges from users.
- 34. Ensure that all employees are well mannered and display courteous behavior.

#### TERMINATION:

IIITDM Kurnool reserves the right to terminate the Contract by giving one month's prior written notice of the same and this agreement will stand terminated on the expiry of the one month period (for notice by IIITDM Kurnool) and 3 months period (for notice by agency) provided always that the Company has fulfilled and complied with all its obligations to IIITDM Kurnool in connection with and under this Agreement at the date of such termination.

### PENALTY:

Failure to supply food in terms of quality, quantity and as per the menu indicated will attract penalty. For not adhering the contractual conditions, the Agency/firm/company Committee shall be free to impose penalty as deemed fir on the agency/firm/company. Penalty imposed will be adjusted against the Security Deposit.

- A. Using poor quality of provisions, items will lead to penalty of Rs. 2,000/- per occasion.
- B. Items like Aji-no-motto, Baking soda, colouring items are banned. Using of the banned items will result penalty of Rs.2,000/- per occasion.
- C. Stall, utensils, and serving items should be kept clean. Any violation will lead to penalty of Rs.2,000/- per occasion.
