Instructions to Shortlisted candidates:

1. As per the instructions received from the Ministry of Education, Govt. of India, the shortlisted candidates for all the positions will have to physically present themselves in the identified CFTIs for the screening test, seminar presentation and interview as per the date and time

mentioned above. However, the candidates for Assistant professor (contract (level 10 and 11)) are required to come prepared to stay for three days, if necessary. Further, candidates will have to make their own arrangements for their stay during the days of selection process.

2. The screening test, seminar presentation and interview will be at the designated CFTI through online mode only.
3. Each shortlisted candidate is required to bring his/her own laptop, charger and data card for screening test, seminar presentation and interview.
4. The candidates are required to provide three options from the list of Institutes given in the Google form on or before 7th December 2020 failing which it is presumed that you are not interested in appearing for the selection process and your name will be withdrawn from the list of shortlisted candidates.
5. The screening test will be of 2 hours duration with 100 objective type questions. Each correct answer carries 1 mark and the wrong answer carries negative mark of 0.25.
6. The Institute shall allot one of the three options given by the candidate and the same will be communicated to the candidates through e-mail only.
7. The candidates have to report in the allotted Institute well in time for verification of credentials and other requirements.
8. The candidate has to produce any Government issued Identity card for verification at reporting Institute.
9. All the candidates are required to produce all the documents in support of claims made in the application for verification at the allotted CFTI.
10. The duration of the seminar presentation shall be 30 minutes for each candidate with 10 minutes earmarked for discussion with the expert members. Your seminar presentation should include presentation of 10 minutes of any core subject topic and 10 minutes on research and other academic credentials.
11. It may be noted that **NO TA/DA is admissible** for attending screening test /Seminar presentation. However, outstation candidates within India, shortlisted for interview on the basis of performance in the seminar presentation, will be paid second AC train fare by the shortest route from place of his/her residence to the town/city of allotted CFTI.
12. Candidates may note that **No change of venue** and date will be entertained.
