2) In the G.O 1st cited, it has been informed that the Government of Tamil Nadu had introduced a scholarship scheme during the year 2019-20, in which the BC/MBC/DNC students of Tamil Nadu whose Parental Annual income is below Rs.2.0 lakh pursuing UG/PG courses in IIT, IIM, NIT, IIIT and other Central Government University could avail scholarship for the actual fees paid or Rs.2.00 Lakh per year whichever is less till the completion of Course.

3) In the ref. 2nd cited, it has also been requested to disseminate it among the students and send the Renewal & Fresh applications for the year 2021-22 to this Department in the application format sent to you through e-mail .

4)In the ref. 3rd cited, Government have enhanced the Parental Annual Income for availing the Scholarship under various Post-Matric Scholarship schemes from Rs. 2.00 lakh to Rs. 2.50 lakh.

5) Consequent to this, it has been decided to extend the last date of submission of fresh and renewal claims under this scheme upto 31.01.2022. I request you to put up the circular (annexed to this letter) on the Notice Board of your institution and make necessary arrangements to obtain the application forms from the eligible students and send those claims to this office within the stipulated time.

This is to inform that the Government of Tamilnadu is implementing Post Matric Scholarship to the students whose native is Tamil Nadu and studying UG/ PG courses in listed institutions IIT, IIM, IIIT, NIT and Central Universities.

A. Eligibility Conditions

1. The student should belong to BC/MBC/DNC
2. The student should be a native of Tamil Nadu.
3. The student should pursue UG/PG Courses in IIT, IIM, IIIT, NIT and Central Universities.
4. The family annual income should not exceed Rs.2.50 Lakh Per Annum.

B. Scholarship Amount

The Govt. of Tamil Nadu have issued orders to grant Scholarship to the tune of Rs.2.00 Lakh per year or the actual fees paid by them whichever is less.
