Important Instructions to the Candidates:

- 1. Candidates must be citizens of India.
- 2. Appointment is purely temporary on Contract Basis and can be terminated at any time without any notice or compensation. The post is initially for the period of One year and extendable on satisfactory performance.
- 3. The appointed person shall have no right/claim for regularization / absorption in IIITDM Kurnool.
- 4. The prescribed qualifications are minimum and unless specified otherwise, they are required for consideration for the notified post, even if higher qualification has been acquired and the mere fact that a candidate possesses the same will not entitle him/her for being called for interview.
- 5. Relevant experience gained after the minimum qualifying degree will only be taken into consideration.
- 6. The Institute reserves the right to restrict the number of candidates for interview to a reasonable limit on the basis of qualifications, level and relevance of experience higher than the minimum prescribed in the advertisement. The Institute also reserves the right of rejecting any or all the applications without assigning any reasons.
- 7. Candidates will be short-listed for Interview on the basis of the information provided by them in their applications. They must ensure that such information is true. If at any subsequent stage or at the time of Interview any information given by them or any claim made by them in their applications is found to be false, their candidature will be rejected.
- 8. The Institute shall verify the antecedents or documents submitted by a candidate at any time at the time of appointment or during the tenure of the post. In case, it is detected that the documents submitted by the candidates are fake or the candidate has clandestine antecedents/background and has suppressed the said information, then his services shall be liable to be terminated.
