Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or

6. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### 3. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

### 4. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- The price quoted by the bidder shall be inclusive of GST.
- Bidders shall upload copies of all relevant documents pertaining to eligibility criteria including copies of valid vehicle RC's, Transport Permits, Drivers License, proof of experience, Turnover, past performance etc . as per GeM Bid and scope.
- The requisition of vehicles is provisional and is subject to change (increase/decrease) depending upon the operational requirements of the Institute and the payment to the contractor during the validity of the contract will be based on the actual utilization and as per the amount quoted by the bidder.
- The vehicles on monthly rental basis should be available 24 X 7 and required relieving drivers must be provided.

It is mandatory for the bidders to attach documentary proof of requisite experience, with the technical bid .
- The contracting agency should have the passenger vehicles, which are being offered for hire on monthly basis, registered as tourist/commercial vehicles in its own name

me having valid commercial permits. Copies of the valid vehicle registration certificates and permits should also be attached with the Technical Bid. If the vehicles are not presently in the tenderer's name, an affidavit duly attested by a Notary that in the event of his being the successful bidder, he will get these vehicles transferred to his name before supplying them to IIITDM Kurnool, should be submitted.

7. whenever the fuel prices increase or decrease by more than 10% of the prices prevailing at the time of commencement of the contract, then the hire charges shall be increased or decreased, as the case may be, by 5% of the original price. quoted.

8. In case of vehicles hired on monthly basis, if the mileage utilization of the vehicle for a particular month, is less than the allowed usage mileage, the shortfall mileage shall be carry forwarded during the validity of the contract and further extensions if any.

9. The Premium SUV vehicle provided on monthly basis shall have bucket seats.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority. While participating in bid, Bidder has to undertake compliance of this and any false declaration and non-compliance of this would be a ground for immediate termination of the contract and further legal action in accordance with the laws./जेम की सामान्य शर्तों के खंड 26 के संदर्भ में भारत के साथ भूमि सीमा साझा करने वाले देश के बिडर से खरीद पर प्रतिबंध के संबंध में भारत के साथ भूमि सीमा साझा करने वाले देश का कोई भी बिडर इस निविदा में बिड देने के लिए तभी पात्र होगा जब वह बिड देने वाला सक्षम प्राधिकारी के पास पंजीकृत हो। बिड में भाग लेते समय बिडर को इसका अनुपालन करना होगा और कोई भी गलत घोषणा किए जाने व इसका अनुपालन न करने पर अनुबंध को तत्काल समाप्त करने और कानून के अनुसार आगे की कानूनी कार्रवाई का आधार होगा।
