7. If there is any addendum/corrigendum related to the Tender, it shall only be published on the Institute website. The Bidders are advised to check the Institute’s website regularly. No other mode of notice will be given.

8. The Bidders are requested to submit the bids after the issue of clarifications duly considering the changes made, if any. Bidders are totally responsible for incorporating/complying with the changes/ amendments issued, if any, during a pre-bid meeting in their bid.

9. Bidders need to submit **self-attested** hard copies with relevant documents.

10. If the last date of receiving/opening of the bids coincides with a holiday, then the next working day shall be the receiving/opening date. Physical submission of financial bids only shall be considered.

11. **Payment Terms (After commencement of work):** Monthly Payment against actual supply and final acceptance by IIITDM Kurnool, on submission of Performance Guarantee.

2. TENDER PROCESSING FEE, EARNEST MONEY DEPOSIT (EMD)

AND PERFORMANCE GUARANTEE

2. Bids received without EMD shall be summarily rejected.
3. The Successful Bidder shall furnish a **Performance Guarantee** (as per the template in **Annexure-VI**) in the form of Bank Guarantee from any nationalized bank within a **Week after issue of Letter of Award (LOA)**. The validity period and amount of Performance Guarantee are specified in the previous table.
4. EMD of Bidder shall be forfeited if the bidder withdraws or amends its bid or impairs or derogates from the bid in any respect within the period of validity of his/her bid.
5. Further, if the successful Bidder fails to furnish the Performance Guarantee within the specified period, his/her EMD shall be forfeited.
6. In case the Bidders / Successful Bidder(s) are found in breach of any condition(s) at any stage of the tender, EMD / Performance Guarantee shall be forfeited.
7. In cases of 4, 5 and 6, apart from forfeiting EMD/Performance Guarantee, the Institute may initiate any penal action against the Bidder/successful Bidder, which the Competent Authority deems to be fit.
8. EMD will be returned to Unsuccessful Bidders without any interest whatsoever, after allotment of LOA.

3. METHOD OF SUBMISSION OF BIDS

1. The bids should be filled in two bid formats (Technical Bid and Financial Bid) with all the required documents as enclosures in separate sealed covers.
2. There should be the main envelope, called a Master envelope, and three more envelopes, namely: Envelope-1, Envelope-2, and Envelope-3.
 - a) Envelope-1: Superscribed as “**EMD for Supply of Water Tankers at IIITDMKNL, Kurnool, Andhra Pradesh**”. The Demand Draft/Banker’s Cheque / EMD exemption declaration (**Annexure- IV**) towards EMD should be kept in this envelope and sealed.
 - b) Envelope-2: Superscribed as “**Technical Bid for Supply of Water Tankers at IIITDMKNL, Kurnool, Andhra Pradesh**”. The complete tender document (downloaded from the websites) along with the required supporting documents needs to be **spiral-bounded** and should be kept in this envelope and sealed.
 - c) Envelope-3: Superscribed as “**Financial Bid for Supply of Water Tankers at IIITDMKNL, Kurnool, Andhra Pradesh**”. The Financial Bid (as per the template in **Annexure-V**) should be kept in this envelope and sealed.
3. All the documents in Envelopes 2 and 3 should be duly **signed by the Bidder with the stamp** of the firm.
4. All these three envelopes, Envelope-1, 2 and 3 should be kept in the **Master envelope**.
5. The master envelope should be super-scribed with the “**Supply of Water Tankers at IIITDM Kurnool, Kurnool, Andhra Pradesh**”.
6. Incomplete bids or bids not submitted in the prescribed format are liable for rejection. Also, the Bids received after the due date and time shall be summarily rejected.

The Bids should be valid for a period of 120 days from the date of opening of the Technical Bid

Note: Before submission of bids, bidders may visit the Institute campus to understand the geographical location of the Institute and bid accordingly.

4. ELIGIBILITY CRITERIA

1. The bidder must have valid GST registration certificate. (**self-attested copy**)
2. Bidder must have a PAN Card (**self-attested copy**).
3. The Bidder should have at least two years of experience in supplying “*Supply of Water Tankers*” in Central Funded Institutions / National Laboratories / Reputed Private Educational Campus / Reputed Private Companies. Copies of purchase orders should be enclosed for this reference.
4. The Bidder must have at least 2 water tankers registered in their name or must have a valid hiring-agreement with the owners.
5. A declaration undertaking on the Letterhead of the Bidder/Agency that all the terms and conditions as given in the tender document are acceptable and the Agency has not been blacklisted by any of the organization at any point of time and no criminal case is pending against the said firm/agency (as per the template in **Annexure-III**) should be given.
6. Each page of the tender document along with all other submitted documents must be duly signed by **authorized signatory** with Bidder’s company seal and initial, otherwise, the document will be invalid. (power of attorney, if any, to be submitted)

5. EVALUATION PROCEDURE

1. Will be a techno-financial evaluation.
2. At the first stage, the Technical Bids will be opened as per the specified date and time in the presence of Bidders, who may like to be present in the Purchase section of the Institute. The Institute will determine the substantial responsiveness of each bid to the tender document. A substantially responsive bid is one which conforms to all the terms and conditions of the bidding/tender document and is without any material defects and deviations. Deviations from, or objections or reservations to critical provisions such as those concerning qualification/eligibility criteria, availability of facilities and amenities as needed, availability of government/statutory approvals and clearances, ready and explicit willingness to accept and honour the terms and conditions of contract etc. will be deemed to be material deviations. If a bid is not substantially responsive, it will be rejected by the Institute and may not subsequently be made responsive by the Bidder by correction of the non-conformity. The financial bids of the responsive bidders would be opened.
3. A Committee duly constituted by the Competent Authority would evaluate the Technical & Financial bids submitted by the Bidders.
4. The Contract will be awarded to the substantially responsive L1 Bidder, i.e. the technically qualified bidder who quotes least price among all the technically qualified bidders. The decision of the Director, IIITDM Kurnool, Kurnool, Andhra Pradesh, is final in this regard.
5. The Bidder should quote their competitive price in the financial bid in figures as well as in words.
6. Tenders with revised/modified rates/offer after the opening of the tenders shall be summarily rejected and the entire Earnest Money Deposit (EMD) submitted with the tender shall be forfeited.
7. The tender is not transferable under any circumstances.
8. Telegraphic, conditional or incomplete tenders shall not be accepted. Canvassing of any kind, direct or indirect, shall lead to disqualification of the Bidder.
9. Institute reserves the right to reject any or all the tenders at any stage or accept them in part or reject the lowest tender without assigning any reason thereof and the decision of the Institute in this respect shall be final.

5. DETAILED SCOPE OF WORK

5.1) SCOPE:

a) Quantity of Water

- i. The frequency of supply of water at the location will be met with daily requirement which is 12,000 liters to 20,000 liters approximately (or) as per the requirement by the IIITDM Kurnool. However, the requirement depends on available water resources & utility at IIITDM Kurnool and hence may either increase or decrease.
- ii. The quantities as mentioned above are approximate and may vary to the extent of the contract amount.

b) Quality of Water

- i. The water should be bore/open well water.
- ii. Water should be clear, potable, totally hygienic, odorless, equivalent to municipal standards for drinking/domestic use.
- iii. Supplier shall submit the test reports of water, (Chemical & Biological) to IIITDM Kurnool, on monthly basis as required from an approved laboratory and the expenses of tests should be borne by the supplier only.
- iv. The tanker used for supplying water should be clean and in satisfactory hygienic condition.

c) CONTRACT PERIOD

The contract is initially for a period of one year, which can be extended for further period of maximum of two years subject to satisfactory performance of the work at the same tendered rate.

- d) Water supplier should be able to supply water on any day including Holidays/ If he fails to deliver in time, IIITDM Kurnool reserves its right to get the same through other agencies. All payments made to other agencies shall be adjusted from contractors balance payments / Security Deposit.
- e) Tanker shall be emptied by the water supplier in Under Ground Tank of IIITDM Kurnool. The driver of water tanker supplier should observe the instructions of Security Guard, Estate section staff & Hostel staff while emptying the tanker into water tank.
- f) The tankers drivers shall strictly observe the traffic rules and should not drive the tankers inside IIITDM Kurnool Campus above the speed of 10 km/hr. If any accident, injuries or harm is sustained by the tankers inside & outside IIITDM Kurnool all the claim, liabilities, compensation will be under the scope of agency to which the concerned tanker belong.
- g) If any damage is caused by the contractor to IIITDM Kurnool or any other damage noticed during the movement of water lorry or otherwise should be made good by the contractor, or the expenditure incurred in this connection will be deducted from payment of water bills.

5. TERMS AND CONDITIONS

Delivery Period / Timelines

The deliveries must be adhered to on an “As and when required basis”. Time is the essence of the contract. It is mandatory for the bidders who respond to this bid to meet this condition.

Liquidated damages

The Institute reserves the right to impose ‘LD clause’ if the supplier fails to perform the contract within the specified period and can even terminate the contract on the whole or in parts thereof.

PERFORMANCE SECURITY DEPOSIT (SD)

- i. Bidder whose tender is accepted, (within seven days) should submit a Security Deposit (SD) in form of demand draft for Rs.20,000/- (Rupees Twenty Thousand only) of any nationalized bank before the agreement with IIITDM Kurnool is entered in to.
- ii. Interest on Security Deposit: No interest shall be paid such security deposit, which shall remain with Institute during the contract period and it shall be released only after the expiry of the contract, subject to clearance of all dues by the contractor.
- iii. Forfeiture of the SD: The whole amount of the security deposit shall be liable to be forfeited in case of breach of any of the terms agreed upon by the contractor. The whole amount of the security deposit shall be liable for forfeiture in event of the contractor not being able to continue the contract for the entire

Bid Validity of both Technical and Financial Bids

Both the technical and financial bids shall remain valid for a period of 120 days after the date of Bid opening prescribed in the Bidding Document. Any Bid valid for a shorter period shall be treated as unresponsive and rejected.

In exceptional cases, the Bidders may be requested by the Institute to extend the validity of their Bids up to a specific period. The Bidders, who agree to extend the Bid validity, are to extend the same without any change or modification of their original Bid and also needs to extend the validity period of the Bid Security accordingly.

In case the day up to which the Bids are to remain valid falls on or subsequently declared a holiday or closed day for IIITDM Kurnool, the Bid validity shall automatically be extended up to the next working day.

Payment

Bi-monthly Payment against actual supply duly verified and acknowledged by the Estate Section (endorsed by the Security & User section) and final acceptance by IIITDM Kurnool, on submission of Performance Guarantee of Rs. 20,000/- valid till warranty period plus a minimum of 2 months.

Penalty for delayed services / LD

- i. Rs.5000/-shall be charged if water is not supplied for consecutive 3 (three) days.
- ii. Security Deposit shall be forfeited if water is not supplied for consecutive 10 (Ten) days.
- iii. If the quality of water supplied is found to be contaminated or not as per drinking standards, the security deposit of the supplier may be forfeited and the contract will be terminated & legal action will be taken against the supplier. Penalty shall be recoverable from the bills of the contractor and / or by adjustment from the security deposit at the discretion of the IIITDM, Kurnool.

Agreement:

The successful bidder shall have to execute a contract agreement with IIITDM Kurnool on a Non-Judicial Stamp Paper of value not less than Rs. 100/- (Rupees Hundred only) within 30 days from the date of award of Order/Contract failing which the EMD shall stand forfeited.

Purchaser's right to vary quantities at the time of the award

IIITDM Kurnool reserves the right at the time of award of the contract to increase or decrease the quantity of items specified in the schedule of requirements without any change in price or other terms and conditions.

Jurisdiction

The disputes, legal matters, court matters, if any, shall be subject to Courts in the district of Kurnool Jurisdiction only.

Force Majeure

- a) IIITDM Kurnool may consider relaxing the penalty and delivery requirements, as specified in this document, if and to the extent that the delay, in performance or other failures to perform its obligations under the contract, is the result of a force majeure.
- b) If the due date of submission of tender/tender opening is declared a holiday for the Institute, the due date for submission of tender/tender will be extended to the same time on next working day.

Arbitration

All disputes of any kind arising out of supply, commissioning, acceptance, warranty maintenance etc., shall be referred by either party (IIITDM Kurnool or the bidder) after issuance of 30 days' notice in writing to the other party clearly mentioning the nature of the dispute and will be referred to the arbitrator to be nominated by The Director, IIITDM Kurnool. The venue for arbitration shall be Kurnool.

Acceptance of the terms and conditions of tender document

The bidders have to accept all the terms and conditions of this tender document and it is made known that the bidders quoting for this tender had impliedly accepted the terms and conditions of this tender.

Interpretation of the clauses in the Tender Document
