A) Instructions to Bidders:

5) Bidders are hereby instructed to check the preliminary criteria & eligibility criteria as mentioned in Buyer uploaded ATC document and to Give number to every docum ent submitted and refer the same in the Eligibility criteria compliance statement and in the proforma for "Profile of the Bidder".

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
