- Seat Acceptance Fee: Rs. 17,500** for candidates with the category tag SC, ST, GEN-PwD, GEN-EWS-PwD, OBC-NCL-PwD, SC-PwD or ST-PwD and **Rs. 35,000** for all other candidates (**the fee includes Rs. 5,000 JoSAA processing charges**). The seat acceptance fee, excluding JoSAA processing charges of Rs. 5000, will be adjusted against the admission fee.

2. **Partial Admission Fee (PAF):** At the end of the 5<sup>th</sup> round of JoSAA 2024, candidates having a provisionally allocated seat (allocated in any round of JoSAA 2024 and which has not been cancelled or withdrawn) are required to pay the **Partial Admission Fee (PAF)** in addition to the **Seat Acceptance Fees (SAF)** from their JoSAA portal.

**Non-payment** of the partial admission fee will be treated as a **rejection of the offered/allocated seat**. Candidates are thus strongly advised to be vigilant and make the payment well within the stipulated time.

**Partial Admission Fee (PAF) is Rs. 20,000** for candidates with the category tag SC, ST, GEN-PwD, GEN-EWS-PwD, OBC-NCL-PwD, SC-PwD or ST-PwD, and **Rs. 45,000** for all other candidates. The partial admission fee will be adjusted against the Institute admission fee. Partial Admission Fee, once paid, **is not refundable**.

3. The JoSAA will remit the total collected amount from a candidate (**after deducting the non-refundable processing charges of Rs. 5,000/-**)

**Rs. 12,500 + 20,000 = 32,500** (for SC, ST, and PwD Candidates)

**Rs. 30,000 + 45,000 = 75,000** (for all other Candidates) to the Institute (IIITDM Kurnool) where the candidate is finally admitted.

4. After paying the partial admission fee on the JoSAA portal, the candidates who are **not participating in CSAB Special rounds** should complete the Institute Registration Process of IIITDM Kurnool as detailed in **Points 05 – 09** below (**Table I**).
5. Candidates who got provisional admission at IIITDM Kurnool (through JoSAA/CSAB-2024) are required to pay the balance Institute fees.

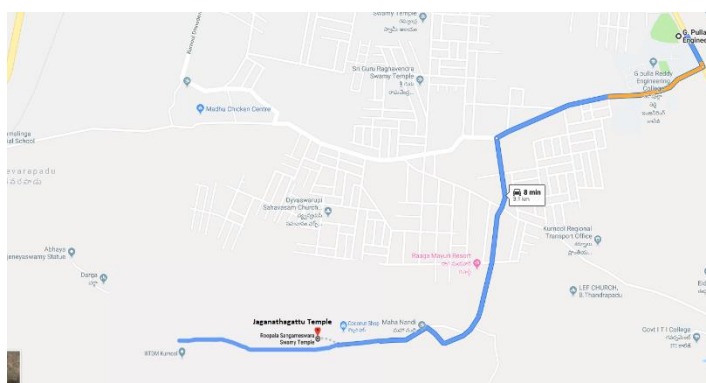

7. **ATM:** Institute has 24X7 ATM (State Bank of India) inside the campus.
8. **Hostel Facility:** Hostel room allotment will be done on the day of physical reporting. Rooms will be allocated on double/triple sharing basis only, as per the Institute rules. No student shall be allowed to return after his/her physical reporting.
9. **Student induction program (SIP)** is a compulsory event for all newly admitted students which is followed by the commencement of the classes.
