- 1. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. Minimum Service charge in 3.85%. In case bidders quote, less than the minimum Service Charge, their b id shall be rejected summarily.
- 2. Consumables & Machinery/Equipment shall be approved by the Institute and the Contractor shall have to provide the same and the amount will be reimbursed at actuals. The prices shall have to be reasonable. Any asset procured with the Institute money will be the asset of the Institute.
- 3. The requirement, category of manpower & their required qualifications mentioned in the scope docume nt is provisional and subject to change based on the operational requirements of the Institute. Based on the requirements, the Contractor shall have to provide the suitable manpower.

- 4. The manpower deployed shall be eligible for the Minimum Wages as declared time to time by the Office of the Chief Labour Commissioner(C), Ministry of Labour & Employment, Govt. of India.
- 5. The minimum Service Charge is 3.85%. Bidders shall quote their bid, as per the values given in the bid by quoting a minimum service of 3.85%. However, Bidders are advised to take into consideration scope an d all the terms & conditions of the tender (Including corrigendum/addendum if any) before submitting their bid. Also, bidders are advised to visit the Institute once to have a proper understanding of the site and the work to be undertaken.
- 6. Eligibility Criteria:
- (a) Bidder must be a proprietor/firm/company possessing valid PWD of Class III or CPWD of Class III (Hort iculture) or CPWD class III (Buildings & Roads) Registration Certificate.
- (b) The average Annual turnover of FY. 2020-21, 2021-22 & 2022-23 should be at least 20 Lakhs issued by CA with UDIN Number.
- (c) The bidder should submit audited financial statements (balance sheets) for the FY 2020-21, 2021-22 & 2022-23 along with relevant income tax returns for the concerned years i.e., AY 2021-22, 2022-23 & 2023-24.
- (d)Bidder must have successfully completed the works pertaining to Horticulture/ Landscaping/ Gardening works with the conditions and value of work/purchase orders along with satisfactory certificates defined as under during the period of 01-04-2021 to 31-03-2024:

One work of Horticulture/Landscaping/Gardening Annual Maintenance Contract costing not less than the amount equal to Rs. 40,00,000/- (Rupees Forty Lakhs only).

OR

Two works of Horticulture/Landscaping/Gardening Annual Maintenance Contract costing not less than the amount equal to Rs. 30,00,000/- (Rupees Thirty Lakhs only).

OR

Three works of Horticulture/Landscaping/Gardening Annual Maintenance Contract costing not less than the amount equal to Rs.20,00,000/- (Rupees Twenty Lakhs only).

- (e) All the payments received against the claim of Work/purchase Orders at Clauses (d) above should refle ct in Form 26AS. Else the Work/Purchase Order is treated as invalid.
- (f) The bidder must have valid GST & PAN Number and the same should reflect in all financial statements.
- (g) The agency shall submit Valid EPFO, ESI, Labour License & Registration copy certificates.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.

- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to gualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य</u> नियम और शर्ते, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
