1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
3. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. Benefits of MSE will be allowed only if the credentials of the service provider are validated on-line in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.
4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

### A) Instructions to Bidders:

1) Pre-Bid Meeting: Bidders shall attend the pre-bid meeting in Hybrid Mode on 23.10.2024 at 04:00 PM. 2) Queries if any may be raised on GeM only. No email queries will be entertained.

3) **Bidders shall quote only the rate per person per day (inclusive of GST & all other charges).**

4) Avoid submitting the same document multiple times.

5) Bidders are hereby instructed to check the preliminary criteria & eligibility criteria as mentioned in Buyer uploaded ATC document and to Give number to every document submitted and refer the same in the Eligibility criteria compliance statement and in the proforma for "Profile of the Bidder".

6) Approx. Student strength is 1000 Nos.

7) Contract Period: The contract is initially for a period of Twelve Months, which may be extended further for a period of 12 Months or part thereof, subject to satisfactory performance of the work and the requirement of the Institute. The decision of the Institute shall be final in the matter.

### **B) Upon Award of the Order/Contract, the successful bidder must:**

1) Obtain the FSSAI Certificate and all other statutory permissions/licenses as applicable and submit the same to the Institute within 15 days. In case of non-compliance, the contractor on whom the order/contract is placed shall be liable for any consequences.

2) Submit a fixed amount of Performance Guarantee of Rs. 10,00,000/- with a validity of 14 months from the start of contract.

3) Submit Security Deposit of Rs. 5,00,000/- in the form of Demand Draft/Bankers Cheque.

### **C) Additional Terms:**

1) Everyday a sample of Breakfast, Lunch, Snack & Dinner prepared shall have to be preserved for atleast 24 hours by the Contractor for Food Quality inspection.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
