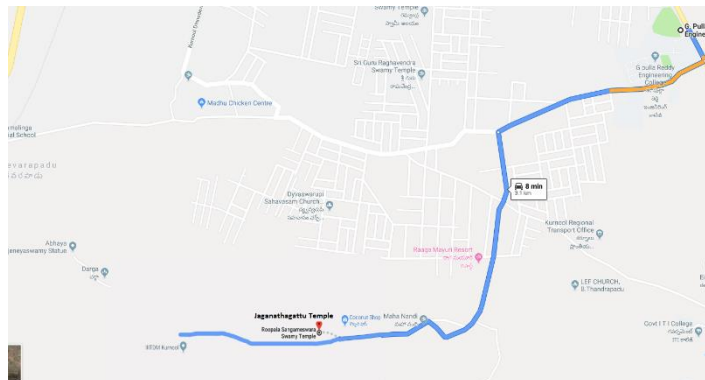

1. **How to reach IIITDM Kurnool:** The campus is about 12 KMs from Kurnool City Railway station, and 3 KMs from G. Pulla Reddy Engineering College, Kurnool. One could get an auto from the Railway station or Bus stop to IIITDM Kurnool. The auto rickshaw will charge approximately Rs. 200. The important landmark in between Kurnool city and IIITDM Kurnool are 1. C-Camp 2. G. Pulla Reddy Engineering College and 3. Jaganathagattu temple.
